









Polls in the wake of the killing of George Floyd showed that the vast majority of Americans, including white Americans, said they support the protests. But now, months later, some signs point to that support ebbing — or even, in places like Wisconsin, potentially being wiped away entirely. They, like most Americans, do not know that the world watches what the country will do as an example of American leadership.

We give thanks to the actions of the African Group (which represents the 54 African countries in the United Nations) who had submitted on June 12th, 2020 a historic request for an Urgent Debate during the Human Rights Council session (June 17-19, 2020) which resumed after it was suspended in March due to COVID-19. This was the same day, June 12th, 2020, that we announced the first Black Folks Plan Black and Blue Public Safety Initiative (BfP/BBPSI) built on our proposed solution to historical institutional racism in the USA.

While the request for an United Nations Human Rights Council (UN/HRC) "Urgent Debate" (which is technically equivalent to a special session) was not specific to the America, it was very clear that racism and impunity for police killings of people of African descent in the United States including the recent killings of George Floyd, Breonna Taylor and Ahmaud Arbery were the impetus for the request when they said, "...The promotion and protection of the human rights and fundamental freedoms of Africans and of People of African descent against police brutality and other violations of human rights".

The U.S. government clearly opposed any such commission of Inquiry. Rivals like China and Russia derided America's longstanding troubles with racial discrimination, and African states insisted that now is the time to help the United States to address and rectify its past shortcomings with racism and police brutality against black citizens once and for all. In a statement to reporters Thursday, June 18th, 2020, U.S. Ambassador Andrew Bremberg acknowledged "shortcomings" in the United States including racial discrimination and that "we are not above scrutiny..." At the same time we updated our BfP/BBPSI on June 19th 2020.

Before that the President on Jan. 8th 2018 signed into law the "400 Years of African-American History Commission Act," which established the 400 Years of African-American History Commission to plan activities to commemorate the 400th anniversary of the arrival of the first Africans in the British Colonies that became the USA. Our actions this year, 2020 are a direct result of actions around that law on August 25th, 2019 at the 1619 400 year Commemoration in the self-declared Year of Remembrance and Return (August 25th, 2019-August 25th 2019, 2020) in Cincinnati Ohio at the Main Public Library with Friends of the African Union, the Georgetown Public Library in Washington DC with African Diaspora Directorate Chairman, its Executive Director and party and at Leimert Park during the monthly Sankofa Village with H.R.H. Prince Nanan Yao Williams Jr. and Lady Alicia Hamilton did agree to the proposed Black Folks Plan contained in this document on pages 3 & 4; these pages are a summary of our UN/HRC submissions in UN Doc. A/HRC/WG.6/36/USA/3.

Through the Black Folks Plan we believe that the United States of America (USA) has another chance through Executive action to restart our country's dialogue around human rights and its citizens of African Heritage around George Floyd's death in Police Custody that has riveted the world and exposed American race relations in the age of a global pandemic that has so far this year taken nearly 200,000 lives in the USA.

My name is Hershel Daniels Junior, I created the Black Folks Plan as Chairman of the Friends of the African Union and serve as Managing Director of the African Diaspora Directorate (AfDiDi). AfDiDi was created as a tool to bring in the USA People of African heritage together in the historic time of Remembrance and Return in the UN International Decade of People of African Descent (ID/PAD). This was before the Global Pandemic and the movement for justice. It is time to leverage their resources and relationships in alignment with each other

To address this need I am calling all People of African Descent (PAD) and their families in the USA in unification through the African Diaspora Directorate. One of our elders said it should operate like the space station whereas you can attach to it your organization without losing your individual identity and or run processes through it that benefit black folk. It will be a tool to connect those in the global African Diaspora by leveraging the power of our American citizenship with those of our Brothers and Sisters in the African Union in the creation of the 6th region Caucus of African Union. To make this a reality we are proposing a 9th Global Pan-African Conference from December 26th 2020 to January 1st 2021. The meeting should produce a unified platform for the PAD in the global African Diaspora as the 6th Region of the African Union; to provide the vision and strategy for cooperative efforts; to discuss, interact, and reach for united solutions and consensus as a group for empowerment of all PAD; to agree on strategies for empowerment of PAD and growth the member organizations and governments; to advocate for staff drawn from PAD in all levels of intergovernmental organizations; advocate for immediate racial justice; and to concentrate using the Universal Periodic Review as our tool for addressing human Rights Concerns with a focus on ending modern slavery while addressing the effects of the past slavery with a global proposal based on the Black Folks Plan for the USA.

According to the US Secretary of State, "Americans work through difficult societal problems openly, knowing their freedoms are protected by the Constitution and a strong rule of law. We are serious about holding individuals and institutions accountable, and our democracy allows us to do so. The United States works every day with partners around the world who share our commitment to fundamental freedoms." We understand that the preamble to the US Constitution makes it a living document that can serve as a 21st century beacon.

The Black Folks Plan operates through licensees and the organization that comes out of the proposed 9th Pan African Caucus would be the vehicle that would implement our solution based on what happens in the United States of America (USA). Today we are 48 days away from a review of Human Rights in the USA by the World. It is called the Universal Periodic Review. Here is what our US State Department Bureau of Democracy, Human Rights, and Labor has to say about this global process that the USA will go through on Nov. 9th 2020: "The Universal Periodic Review (UPR) is a process through which all UN Member States are provided the opportunity to review the human rights records of all other Member States. At the same time, each State under review has the opportunity to report on human rights conditions within their own borders, including actions that have been taken to address concerns detailed by other States. The USA is a strong supporter of the UPR process, which provides a unique avenue for the global community to discuss human rights around the world.

Individual countries are scheduled for review every four and a half years, with the United States due for its third review in May 2020 (NOTE: Because of COVID19 now November 9th 2020). UPR sessions take place in Geneva three times a year and are orchestrated by the Office of the High Commissioner for Human Rights starting from a report submitted by the national government of the country under review. Previous UPR reports submitted by the United States Government reflect significant interagency input, as well as consideration of information collected via consultations with civil society and the American public. Non-governmental organizations (NGOs) can participate in the UPR process. NGOs can submit information which can be added to the "other stakeholders" report which is considered during the review. Information they provide can be referred to by any of the States taking part in the interactive discussion during the review at the Working Group meeting. NGOs can attend the UPR Working Group sessions and can make statements at the regular session of the Human Rights Council when the outcome of the State reviews are considered. OHCHR has released "NGOs, academics, civil society, and the general public are welcome to submit information for the upcoming U.S. - we did. On the following two pages we recreate the summary for the reader that we turned in.

President Trump said in remarks at the 2019 National Historically Black Colleges and Universities Week Conference on September 10, 2019, "The first and highest duty of government is to take care of its own citizens. African Americans built this nation through generations of blood, sweat, and tears. And you, like all of our citizens, are entitled to a government that puts your needs, your interests, and your families first."

The African Diaspora Directorate is looking to create a public-private partnership with US State Department based on statements and actions of the President and our submission to the Third Cycle of the United Nations Universal Periodic Review of the United States with this statement:

The African Diaspora Directorate, its affiliates, members and co-founders Sons and Daughters of Africa, the African American Agriculturalist Association, the Black Wall Street Cooperative, the Universal Negro Improvement Association & African Communities League and Friends of the African Union believe that executive action by the United States Government of a Federal Reserve Quantitative Easing based debt purchasing program (The Daniels IDIQ), in a public-private partnership, that can be a solution for the fundamental injustice, cruelty, brutality, and inhumanity of African people enslaved in chattel slavery in the United States of America, from 1789 to 1866, as well as the progenitors to the United States of America, the 13 British colonies between 1619 to 1789. It will also address the damage incurred by past & current federal government racism against freed African Slaves in the United States of America from 1863 to 1868 and subsequently de jure and de facto of institutionalized systematic racial and economic discrimination against American citizens of African Heritage from 1868 to 2019. It will be a stimulus to the American Economy that:

- (1) is judicious & addresses solutions to lead poisoning in 7M domestic dwellings;
- (2) answers under the control of our Federal Executive Branch to the statements in the inter-agency response set forth by the US State Department to the United Nations Universal Periodic Review of the USA in 2015 that said "Civil Rights, Ethnic, & Racial Discrimination" is the number one human rights problem of the country;
- (3) can draw on already established Executive Authority by the US State Department with no action needed by Congress and can be executed by May 1st, 2020;
- (4) helps the other American citizens through indirect associations by the creation of supportive ancillary jobs, entrepreneurial opportunities and sustainable economic growth thereby supporting the advancement of the American people as a whole, and;
- (5) is just adequate enough to implement real changes that reverse long-standing conditions caused by systemic de jure and de facto of racial and economic discrimination, as documented in depth elsewhere, that provides a means from 2020 to 2095 to address these issues with a 75-year capital trust to do so based on a updated to third cycle Daniels IDIQ and the \$150B in current bank based community benefit agreements in place that were driven by the Community Reinvestment Act.

**Note 1**: 2016 Reparations Update - Accounting for inflation through 2019, the #BlackFolksPlan, with an interim update on February 4th 2020, if we use the \$20,000 that the Japanese received for 3 years in Concentration Camps (1942-1945), then we asked for funding it would be \$1,114,463.18 per person in 2020 dollars if applied to the 4,660,920 Africans in 1866, at the end of the civil war, August 20 1866. Then the total amount is \$5,194,423,160,011.97 or \$5.2T with an additional \$800B in Damages as citizens from July 28th 1868 to August 25th 2019 for a total of \$6T Reparations ask for Black Folk in 2020. To do this we are submitting an unsolicited proposal 30 days before Nov. 9th 2020. An Unsolicited proposal is a written application for a new or innovative idea submitted to an agency on the initiative of the offeror for the purpose of obtaining a contract with the government, and is not in response to a request for proposals, Broad Agency Announcement, Program Research and Development Announcement, or any other Government-initiated solicitation or program. The Department of State (DoS) accepts the submission of valid unsolicited proposals through the Office of the Procurement Executive which contribute new and innovative ideas consistent with the Agency's mission, ours does.

As of December 30th 2019 the African Diaspora Directorate has seven divisions:

- (1) a General Assembly with three operational chambers: a People's Congress, a Civil Society Organizational Congress and an Assembly of State Leaders;
- (2) a African Diaspora Secretariat was established in the USA by August 25th, 2019 under management by Friends of the African Union through 2024. On 1 February 2020 it will go public and recruit new members;
- (3) The African Diaspora Royal Society which is governed by The African Diaspora Directorate Royal Council. The Society is a membership of those of African Tribal Royalty in the global African Diaspora, the tribe in Ghana created for those in the global African Diaspora without a tribe, African Tribal Royalty that welcome members of the African Diaspora in them and or tribes recognized by them for the members of the African Diaspora;
- (4) a Civil Society Bureau will work with the African Union's (AU) Citizens and Diaspora Directorate (AU/CIDO) to implement the AU's engagement process with non-state actors through the involvement of the African Diaspora's Civil Society through AU/CIDO;
- (5) a Diaspora Bureau will organize at a national, regional and or state geographic and Tribal level in the people of African Descent in the global African Diaspora who are African nationals. We are currently focused on Civil Society Organizations (CSOs) in line with AU's Economic, Social and Cultural Council, the United Nations, the European Union, Organization of American States along with other international and or multinational organizations;
- (6) a Operations Bureau who will create and operate the partnerships and businesses called for by the organs of the African Diaspora Directorate Secretariat; and,
- (7) The Business Operations Bureau shall create business corporations organized for profit with a corporate purpose of creating general public benefit for the People of the African Diaspora (PAD). These benefit corporations offer PAD entrepreneurs and investors the option to build, and invest in, businesses that operate in a socially and environmentally responsible manner.

In addition, we recognize that economic opportunity is the greatest engine for empowering human rights for individuals and families to overcome adversity, and through this proposal will continue to fight for opportunity for all Americans with a focus on American citizens of African Heritage. **During the historic 2020 year we will work to implement at a local level the BlackFolksPlan.org.** We started in Philadelphia on 1.16.20 and now around the nation through this proposal.

Note 2: We submitted to solutions the first a Joint submission 25 submitted by: Friends of the African Union; New Future Foundation; The African Diaspora Directorate, Friends of African Union EDcorp; Friends of Africans Union PBFS, Congress of Black Native Americans; Infinity Building Economics/Black Political Action Committee; Friends of African Union smartWISE; Black Methodist for Church Renewal Chapter of Keys of the Kingdom; United Methodist Church; Congress of Black Native Americans; Infinity Building Economics/Black Political Action Committee; Friends of Africans Union Mighty Forefront; Friends of Africans Union Ghana; Sons and Daughters of Africa; Friends of African Union Zimbabwe; Friends of African Union Ethopia; The Universal Negro Improvement Association and African Communities League; The Town of Forth Coffee; and CASH Community Development focused on Black Folk that was based on the creation of local coalitions that we call FAU smartWISE Community Reinvestment Coalotions to drive local the detailed use of proceeds in our \$6T 75 year proposal. The implementation agent for this is the African Diaspora Directorate.

The African Diaspora Directorate Business Operations Bureau would sign memorandums of understanding with all parties in the production of the proposed 9th Global Pan-African Conference from December 26th 2020 to January 1st 2021. This would include asking governments, intergovernmental agencies like the United Nations as well as organs of the African Union to participate.
